## **GAF 500 Roofing Accessories Rewards Program Terms and Conditions (“Terms”)**

### **1. Eligibility**

The GAF 500 Roofing Accessories Rewards Program (the “Program”) is open to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older as of the date of registration in the Program. The Program begins on Thursday, March 1, 2018 at 12:00:00AM ET and ends on Thursday, May 31, 2018 at 11:59:59PM ET (the “Program Period”).

### **2. How to Participate**

Purchase Qualifying GAF Accessories (listed in Section 9 below) at Lowe’s stores in the U.S. or online during the Program Period (each, a “Qualifying Purchase”), take a clear photo of your entire original receipt for a Qualifying Purchase (each, a “Receipt”) and submit the Receipt using one of the following submission methods:

By texting GAF to 811811, you consent to receive up to eight (8) promotional text messages per Receipt submitted (pertaining to this Program only), via an automatic telephone dialing system to the number you provided, from Snipp Interactive on behalf GAF Materials LLC. Text HELP for help and STOP to opt-out. Your consent to the above is not required to make a purchase. Message & Data Rates May Apply. After submitting a Receipt, register for the Program using the link provided to you via text.
- b) **EMAIL:** Email the Receipt to [Redeem@GAF500.com](mailto:Redeem@GAF500.com) and register for the Program using the link provided to you via email.
- c) **WEB:** Visit [www.GAF500.com](http://www.GAF500.com) (the “Website”), and follow the instructions for uploading a Receipt and registering for the Program.

To ensure that your Receipts are processed quickly, put a check mark next to the purchase date and each Qualifying GAF Accessory on the Receipt before submitting.

Multiple Receipts can be submitted to reach the total amount of Qualifying Purchases required to earn one or more Lowe’s eGift cards. Submit only one Receipt at a time. Submit a Receipt only one time. All Receipts are subject to verification. Allow approximately forty-eight (48) hours for verification of each Receipt submitted. A Receipt that cannot be validated for any reason will be rejected. Retain the original receipt for any Qualifying Purchase that you submit. Sponsor reserves the right, in its sole discretion, to audit Receipt submissions and to require you to provide additional information including, but not limited to, original sales receipts. Duplicate Receipts and Receipts that are tampered with, or obtained through unauthorized means or illegitimate channels will be void and may result in your disqualification from the Program.

**All Receipts must be received by 11:59:59 PM ET on June 14, 2018 to qualify.**

### 3. Rewards

You will earn one (1) \$50 Lowe's eGift card for each Qualifying Purchase of \$250 up to \$1,000 and one (1) \$75 Lowe's eGift card for each Qualifying Purchase of \$250 between \$1,000 and \$2,000. You may submit a maximum of \$2,000 in Qualifying Purchases and earn a maximum of (4) \$50 Lowe's eGift Cards and four (4) \$75 Lowe's eGift cards during the entire Program. The Program is void where taxed, prohibited, or restricted by law.

You can view the total amount of Qualifying Purchases that you have submitted and the Lowe's eGift Cards that you have earned by using the Check Status tab on the Website. Allow approximately 48 hours from the time that you submit a Receipt or receive a Lowe's eGift Card for changes to be reflected.

### 4. Text Messaging (SMS) Terms And Restrictions

By texting "**GAF**" to 811811, you consent to receive up to eight (8) promotional text messages per Receipt submitted (pertaining to this Program only), via an automatic telephone dialing system to the number you provided, from Snipp on behalf of GAF Materials LLC. Standard message and data rates may apply. Your consent to the above is not required to make a purchase. You may text HELP to 811811 at any time for help, or text STOP to opt-out. **Carrier specific charges for text messages may apply, including error messages, depending on your individual cellular pricing plan, in accordance with your cellular customer agreement.** SMS may not be available for all service providers or for all handsets. Cellular phone carrier's instructions for text messaging may be different. Check your phone capabilities and service provider for specific instructions. Sponsor makes no guarantee that any particular wireless service provider will be compatible with this Program. Participant is responsible for all applicable fees and taxes associated with Program participation. Sponsor, in its sole discretion, may add or delete a cellular carrier at any time, without notice.

## **5. Release**

By participating in the Program, you agree to release, discharge, indemnify and hold harmless GAF, Snipp Interactive, Lowe's Companies, Inc. and their respective parent companies, subsidiaries, affiliates, retailers, and advertising and promotion agencies, and each of their respective officers, directors, shareholders, employees and agents (collectively, "Released Parties") from any liability or damages arising out of or related to participation in the Program, the Terms or the acceptance, use, misuse or possession of any product, service or reward obtained through this Program. All applicable federal, state and local laws and regulations apply.

The Released Parties are not responsible for late, lost, incomplete, illegible, delayed, inaccurate, garbled, undelivered, misdirected requests, email, texts, or mail, or other errors or problems of any kind relating to or in connection with the Program, whether printing, typographical, technical, computer, network, human, mechanical, electronic or otherwise, including, without limitation, errors or problems which may occur in connection with the administration of the Program or in any Program-related materials. Persons found tampering with or abusing any aspect of this Program, who are acting in a disruptive or unsportsmanlike manner or who are otherwise not in compliance with these Terms, as solely determined by Released Parties will not be eligible. Released Parties are not responsible for injury or damage to your computer or mobile device or to any other person's computer or mobile device related to or resulting from participation in this Program. The Released Parties are not responsible for late, lost, stolen, damaged, delayed or undelivered Lowe's eGift Cards.

## **6. Disputes**

By participating in the Program, you and the Sponsor (each, a "Party" and collectively, the "Parties") agree to make a diligent, commercially reasonable attempt to resolve any disputes arising out of or concerning your participation in the Program, these Terms or the acceptance, use, misuse or possession of any product, service or reward obtained through this Program. If the Parties are unable to resolve a dispute within 15 days after notice from one Party to the other, such dispute shall be settled by final and binding arbitration by a single arbitrator in accordance with the Commercial Arbitration Rules of the American Arbitration Association (the "AAA") at the offices of the AAA in the state nearest the location of your primary residence. Within thirty (30) days after an arbitrator has been selected, the Parties shall provide all documents and electronically stored information ("ESI") related to or necessary to the prosecution or defense of any claim, defense or legal theory presented in the arbitration by either Party. The Parties shall only be required to produce ESI that is stored in a reasonably accessible medium. No other document requests, interrogatories or requests for admissions shall be permitted. If a Party desires to file a dispositive motion, that Party must first submit a letter to the arbitrator outlining the legal and factual issues that it contends are ripe for summary disposition. The opposing Party shall have five (5) days to submit a letter detailing its position on the requested motion. Within two (2) weeks of submission of the opposing Party's letter, the arbitrator shall determine whether the requesting Party shall be permitted to file a dispositive motion. The decision of the arbitrator shall be final and binding upon the Parties and shall be set forth in a written reasoned opinion, and any award may be enforced by either Party in any court of competent jurisdiction. Any award of the arbitrator shall include interest from the date of any damages incurred for breach or other violation of these Terms, and from the date of the award until paid in full, at the rate of one percent (1%) per month compounded monthly. Except as may

be required by law, the Parties may disclose the existence, content or results of any arbitration hereunder without the prior written consent of the other Party.

THE ARBITRATION OF DISPUTES PURSUANT TO THESE TERMS SHALL BE IN AN INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. YOU AGREE THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH PARTICIPATION IN THE PROGRAM, THESE TERMS OR THE ACCEPTANCE, USE, MISUSE OR POSSESSION OF ANY PRODUCT, SERVICE OR REWARD OBTAINED THROUGH THIS PROGRAM. WILL BE RESOLVED INDIVIDUALLY THROUGH BINDING ARBITRATION AS SET FORTH ABOVE, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; UNDER NO CIRCUMSTANCES WILL YOU BE PERMITTED TO OBTAIN ANY AWARD FOR, AND YOU HEREBY KNOWINGLY AND EXPRESSLY WAIVE ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES, AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND YOU IRREVOCABLY WAIVE ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY.

In the event that the claimant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, the Sponsor will pay as much of the claimant's filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal (other than that claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by the AAA, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor GAF shall be entitled to arbitrate their dispute.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Terms or the rights and obligations of the entrant and Sponsor in connection with the Program shall be governed by, and construed in accordance the substantive laws of the State of Delaware without reference to its conflict of laws principles. All remedies shall be cumulative and not exclusive. The failure of GAF to comply with these Terms because of an act of God, war, fire, riot, terrorism, earthquake, actions of federal, state or local governmental authorities or for any other reason beyond the reasonable control of GAF, shall not be deemed a breach of these Terms. If GAF fails to act with respect to your breach or anyone else's breach on any occasion, GAF is not waiving its right to act with respect to future or similar breaches. If any provision of these Terms shall be unlawful, void or for any reason unenforceable, then that

provision shall be deemed severable from these Terms of use and shall not affect the validity and enforceability of any remaining provisions.

## **7. Privacy Policy**
