

Sanofi (Chattem, Inc.) – Rise to the Challenge

Terms and Conditions

1. Eligibility

Rise to the Challenge Rebate Program (the “Program”) begins **Sunday, April 26, 2020** at 12:00:01 AM Eastern Standard Time ("EST") and ends on the earlier of **Saturday, June 13, 2020** at 11:59:59 PM EST or when rebates totaling Twenty-Five Thousand Dollars (\$25,000) have been issued by Sponsor (“Rebate Period”). Participation in the Program is limited to legal residents of the 50 United States, the District of Columbia, and Puerto Rico who are 18 years of age or older.

2. Rebate Program
