HENKEL SPRING CLEANING CONTEST CONTEST RULES AND REGULATIONS Official Rules

NO PURCHASE IS NECESSARY. By entering this Contest, entrants agree to abide by these Official Rules. The decisions of the Independent Contest Organization with respect to all aspects of the Contest are final.

- SPONSOR & CONTEST PERIOD: The Henkel Spring Cleaning Contest (the "Contest") is sponsored by Henkel Consumer Goods Canada Inc., an Ontario Corporation (the "Sponsor"). The Contest commences at 12:00:00 AM Eastern Time ("ET") on April 1, 2019 and will end at 11:59:59 PM ET on May 31, 2019 (the "Contest Period"). All times are Eastern Times. Entries must be received by 11:59:59 PM ET on June 14, 2019 (the "Grace Period End Date").
- 2. **ELIGIBILITY:** To enter the Contest and be eligible to win the grand prize (see rule 5), a person ("**Entrant**") must be a legal resident of Canada who, at the time of entry, has reached the legal age of majority in the province/territory in which he/she resides. Employees, officers, and directors of the Sponsor, its affiliates, representatives, agents, participating stores, advertising or promotional agencies, and the independent contest organization (collectively the "**Contest Parties**") and immediate members and members of the same household of such persons, whether related or not, are not eligible to enter the Contest. For these Official Rules, "immediate family" means mother, father, sister, brother, son, daughter and spouse, including common law spouse, regardless of where they reside.

The purchase of the three (3) **Participating Products** Receipt. must (1) sales Next. appear one visit CleanUpWithSavings.com (the "Contest Website") and complete the registration form (the "Registration Form") with your full name, your mailing address, a valid email address and daytime telephone number (including area code); check the box to confirm that you are entering the Contest and are in compliance with these Official Rules; check the box to confirm that you are the legal age of majority or older at time of entering the Contest; upload a Photo of your Receipt and click submit. The Photo must be under 10 MB and must be either a jpeg, png, bmp or PDF. Your Receipt will then be reviewed by the Sponsor (or its designated representative(s)) within 72 hours to determine if it meets the above requirements. If deemed eligible, you will receive one (1) entry (the "With Purchase Entry") into the grand prize draw (see rule 6). Your purchase may be made at any retail store in Canada that sells the participating Henkel products. Receipt must be uploaded by the Grace Period End Date.
 - Without Purchase: Visit a participating retail store in Canada during regular store hours during
 the Contest Period and locate three (3) participating Henkel Products and record the UPC of each
 participating Henkel Product (the "UPC"). The UPC can be found on the Henkel Product

packaging. Next, on a plain piece of paper, hand-print your full name, province or territory of residence, daytime telephone number (including area code), a valid email address, the following statement: "I have read, understand and agree to the Contest Official Rules"; record the three (3) UPCs and mail with sufficient postage to: The Henkel Spring Cleaning Program, Dept 3986, Box 9500 Lakeshore West PO, Oakville ON, L6K 0G4 (the "No Purchase Entry"). Upon verification, you will receive one (1) entry into the grand prize draw (see rule 6). Each No Purchase Entry must be an original (no photocopies or other reproductions) and mailed in a separate envelope, bearing sufficient postage. No Purchase Entries must be received prior to the Grace Period End Date.

- 4. **ENTRIES:** Each "No Purchase Entry" and "With Purchase Entry" will be collectively referred to as an "Entry". A person may enter the Contest up to three (3) times during the Contest Period regardless of the method of entry and receive up to a maximum of three (3) Entries (regardless of the method of entry). Only one (1) email account per person may be used to enter the Contest. Any person who is found to have entered in a fashion not sanctioned by these Official Rules and/or who has submitted more than the number of Entries permitted by these Official Rules will be disqualified. Proof of transmission (screenshots or captures, etc.) does not constitute proof of delivery. Entries generated by script, macro, robotic, programmed, or any automated or other means not in keeping with the Sponsor's interpretation of the letter and spirit of these Official Rules are prohibited and will be disqualified. The Sponsor will not be responsible for late, lost, illegible, falsified, damaged, misdirected, mutilated, garbled or incomplete Entries, which will be void. All Entries become the property of the Sponsor upon receipt and none will be returned.
- 5. **GRAND PRIZE:** There is one (1) grand prize (the "**Grand Prize**") available to be won consisting of one (1) LG TWINWASH® Washer and Dryer. The total approximate retail value of the Grand Prize is \$4,000.00 (CAD). Delivery and Installation included. If the Winner would like additional accessories or options, they must purchase through a distributor. The Grand Prize must be installed and assembled according to the manufacturer's assembly guide and recommendations.

The Grand Prize must be accepted as awarded without substitution, is not transferable, not for resale and has no cash surrender value. The Sponsor reserves the right, in the event that the Grand Prize or any component of the Grand Prize cannot be awarded as described, or becomes unavailable for any reason, to substitute another Prize or component of a Prize of equal or greater value. 6. **GRAND PRIZE DRAW:** One (1) random Grand Prize draw will be held at 10:00:00 AM ET on July 2, 2019 (the "**Draw Date**") in Oakville, ON from among all eligible Entries received up to the end date of the Grace Period (see rule 1) to determine the Grand Prize selected entrant. Odds of being selected for the Grand Prize depend on the total number of eligible Entries received. The selected entrant will be contacted by telephone and/or email within three (3) business days of the Draw Date. If the selected entrant (a) cannot be reached by telephone and/or email within five (5) business days of the first notification; (b) fails to correctly answer the skill testing question (see rule 7); or (c) fails to return the properly executed Release Form within the specified time (see rule 7), then he/she will be disqualified and another entrant may, in the sole discretion of the Sponsor and time-permitting, be randomly selected until such time as a winner is

- 9. **GENERAL:** The Released Parties do not assume any responsibility for (i) the incorrect or inaccurate capture of entry information and Entries that fail to comply with these Official Rules; (ii) any loss, damage, or claims caused by an awarded Prize or the Contest itself; or (iii) any failure of the Contest Website, including any problems, human or technical, printing errors, lost, delayed, garbled data or transmissions, omissions, interruptions, deletions, defects or failures of any telephone or computer lines, or technical malfunction of any computer on-line systems, servers, access providers, computer equipment, software, failure of any e-mail or entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof including any injury or damage to an entrant's or any other person's computer related to or resulting from downloading any material connected to the Contest, all of which may affect a person's ability to participate in the Contest. The Sponsor reserves the right, with the consent of the Régie des alcools, des courses et des jeux (the "**Regie**"), to terminate or suspend this Contest or to amend the Official Rules at any time and in any way, without prior notice. Without limiting the foregoing, if, for any reason, the Contest is not capable of running as originally planned, the Sponsor reserves the right, with the consent of the Régie, to cancel the Contest and conduct a draw from all previously received eligible Entries in accordance with the applicable procedures outlined in these Official Rules. The Released Parties shall not be held responsible for any problems, errors or negligence that may arise or occur in connection with the Contest.

- 11. **For Quebec residents only.** Any litigation respecting the conduct or organization of a publicity contest in Québec may be submitted to the Régie for a ruling. Any litigation respecting the awarding of the Prize may be submitted to the board only for the purpose of helping the parties reach a settlement.
