**PURCHASE IS NECESSARY. INTERNET ACCESS AND A VALID E-MAIL ACCOUNT ARE REQUIRED. **1. AGREEMENT TO BE LEGALLY BOUND BY TERMS AND CONDITIONS**

**2. ELIGIBILITY**
