## KRAFT HEINZ HOLIDAY RECIPE UPLOAD CONTEST OFFICIAL RULES

THIS CONTEST IS DESIGNED AS A SKILL CONTEST. CHANCE PLAYS NO ROLE IN THE DETERMINATION OF WINNERS. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING, VOID WHERE PROHIBITED BY LAW.

EXCEPT FOR THE MARKS OF THE SPONSOR, ENTRY MUST NOT CONTAIN ANY THIRD-PARTY TRADEMARKS, LOGOS, TRADE DRESS OR PROMOTION OF ANY BRAND, PRODUCT, OR SERVICE.

The "Kraft Heinz Holiday Recipe Upload Contest" (the "Contest") is organized by Kraft Heinz Canada ULC. (the "Contest Organizer"). The Contest Organizer's address is 95 Moatfield Dr, Toronto, Ontario, M3B 3L6. The Contest Organizer is responsible for the Contest, its organization and the Contest Rules (collectively the "Rules").

**1. ELIGIBILITY**: The Contest begins on October 19, 2022 at 12:01 a.m. Eastern Time ("<u>ET</u>") and ends on December 28, 2022 at 11:59 p.m. Eastern Standard Time ("EST") ("<u>Contest Period</u>"). The time shall be determined by Contest Organizer's timekeeping systems, and Contest Organizer may also rely on the time processing functions of third parties. Contest Organizer shall have the sole discretion in determining the timeliness of any action or inaction related to this Contest.

The Contest is only open to Entrants who:

- (1) are legal residents of, and physically located within Canada (the "Eligibility Area");
- (2) have reached the legal age of majority in their respective province or territory of residence as of the time of Entry;
  - (3) agree to be bound by the terms of these Rules; and
  - (4) submit a valid Entry (as defined below) (each, an "Entrant", or "you").

The Contest is not open to Entrants who:

- (a) are employees, shareholders, subsidiaries, affiliates, officers, directors, agents and representatives of Contest Organizer or any entity which is involved in any aspect of the creation, production, operation, execution or fulfilment of the Contest (such entities, the "Contest Organizer Affiliates");
- (b) are immediate family members (defined as parents, children, siblings, domestic partner, husband, or wife) or household members (defined as those people who share the same residence of such Entrant at least three (3) months a year) of such individuals listed in clause (1) above;
  - (c) are prohibited by applicable law from entering the Promotion; or
  - (d) do not meet any of the eligibility requirements set forth above.

- **2. TO ENTER:** To enter the Contest, complete the following steps during the Contest period:
- (1) Visit <a href="https://GiftOfDelicious.ca">https://GiftOfDelicious.ca</a> (the "Contest Site"), where you will be required to complete an entry form, including providing the answer to a mathematical skill-testing question (which you must answer correctly without any mechanical, electronic or other assistance). Follow all posted instructions to complete the entry form.
  - (2) Take one (1) original photo of a prepared food dish featuring one (1) or more Kraft Heinz products.
- (3) Upload your photo entry to the Contest Site. Each such completed and validly submitted entry including the photograph of an original prepared food dish, an "Entry"

All Entries must be received by **December 28, 2022 at 11:59 p.m. EST.** 

Limit of one (1) entry per person.

Contest Organizer is not responsible for lost, late, misdirected entries or entries not received regardless of cause. In the event of a dispute over who submitted an Entry, the Entry will be deemed to have been directly submitted by the authorized account holder of the relevant account used to enter the Contest. The authorized account holder is deemed to be the natural person who is assigned to the account by the relevant entity responsible for assigning those accounts. By entering and/or participating, Entrants agree to be bound by these Official Rules and Contest Organizer's website Terms of Use Privacy Policy as set forth in these Official Rules.

**3. REQUIRED REPRESENTATIONS AND WARRANTIES:** You must meet all the following as applicable to your Entry. Failure to do so may result in your disqualification.

By entering, you represent and warrant regarding your Entry:

- (1) It is your own original work, or you must have all the rights necessary to post or re-post the content. Each Entry must not contain any material that would violate or infringe upon the rights of any person or entity, including without limitation copyrights, trademarks or rights of privacy or publicity, or that is defamatory, threatening, indecent, obscene or offensive, or that is unlawful, in violation of or contrary to any applicable laws or regulations, or which requires a license from any third party. For all video Entries, please note that the video must be solely your own work, including but not limited to, the actual filming, editing, graphic design, etc. of the video.
  - (2) Your Entry cannot have been selected as a winner in any other contest;
- (3) You have the express written consent of any identifiable persons appearing or referenced in your Entry or Entries to their Persona (as defined below) being used in the ways set out in these Official Rules, including Contest Organizer's right to use your Entry or Entries for any future commercial purpose without restrictions. Upon request, you will obtain written consent of any such persons for Contest Organizer in the form identified by Contest Organizer.
- (4) No person appearing in any Entry is under the legal age of majority in their respective province or territory of residence.
- (5) Except for the marks of the Contest Organizer (addressed below), the Entry does not reference any person other than Entrant, or any names, products or services of any company or entity or any third-party trademarks, logos, copyrights, trade dress or promotion of any brand, product, or service. Contest Organizer grants you the limited permission to use its marks in your Entry solely for purposes of entering. You shall immediately cease any and all use of the Contest Organizer marks upon expiration or termination of this Contest.
- (6) Your Entry is appropriate for public viewing. Without limiting the foregoing, your Entry is not lewd, obscene, sexually explicit, pornographic, disparaging, defamatory, libelous, or otherwise contain content which Contest Organizer in its sole discretion decides is inappropriate or objectionable, including without limitation communicating messages that may reflect negatively on the goodwill of Contest Organizer. Your Entry or Entries must also not disparage or cast a negative light on any person, entity, or brand, product, or service.

Contest Organizer reserves the right in its sole and absolute discretion to not consider any Entry for the Contest if it believes the Entry violates or potentially violates any of the foregoing requirements or otherwise fails to comply with any provision of these Official Rules. Entrant agrees to reimburse Contest Organizer in full in respect of any losses, damages, and expenses, including reasonable legal fees (including, where permitted, reasonable attorney fees) that they may sustain from the breach of a representation or warranty made by you or the use of any rights granted by you to Contest Organizer hereunder. By entering, you warrant that your Entry or Entries comply with the requirements set out above including those at (1) - (6) above. By entering, you will and hereby do grant to Contest Organizer a perpetual, irrevocable, exclusive, worldwide, royalty-free, sub-licensable, freely assignable license to reproduce your Entry and to otherwise use, exploit, copy, modify, adapt, edit, publish and display the Entry in any form, manner, venue, media or technology now known or later developed for any and all purposes, including, without limitation, for purposes of commercial or trade purposes, advertising, and promotion as Contest Organizer and its licensees or

assignees determine, without further compensation, notification, or permission. Further, by entering, you hereby waive any moral rights you may have in any Entry in favor of the Contest Organizer.

By submitting your Entry you also grant to Contest Organizer the worldwide, perpetual, irrevocable, fully sub-licensable, and freely transferable right, but not the obligation, to use any and all names, identities, titles, likenesses, distinctive appearances, physical likenesses, images, portraits, pictures, photographs (whether still or moving), screen personas, voices, vocal styles, statements, gestures, mannerisms, personalities, performance characteristics, biographical data, signatures, and any other indicia or imitations of identity or likeness listed, provided, referenced, or otherwise contained in the Entry and/or image (all attributes, collectively, per person, a "Persona") for purposes of advertising and trade, in any format, medium, or technology now known or later developed without further notice, approval, or compensation, unless prohibited by law.

## 4. WINNER SELECTION; NOTIFICATION:

On January 6, 2023, a panel of qualified judges selected in Contest Organizer's sole discretion (the "Panel") will select potential prize winners from among the eligible Entries received in accordance with these Official Rules and based on the following judging criteria ("Judging Criteria"), weighted in Contest Organizer's sole discretion: (a) creativity, inspiration & originality of the food dish; (b) appearance/presentation, (c) overall appeal; and (d) clarity of ingredient list and recipe directions.

The selected winner is subject to verification of eligibility and compliance with these Rules. **Limit one (1) Prize per person and per household.** 

For the abundance of caution it is hereby clarified that the Panel may review multiple Entries that submit similar Entries; in such a case, the Panel may consider the timing of such Entries in making its decision but will not be bound to designate as a potential winner the first submission of such similar Entries. The selected winner is subject to verification of eligibility and compliance with these Official Rules.

If Contest Organizer does not receive a sufficient number of Entries meeting the Entry requirements, Contest Organizer may, at our discretion, select fewer winners than the number of Prizes described below.

Potential winner(s) will be notified via the contact information provided during entry no more than 15 days following judging with prize claim instructions, including submission deadlines. If potential winners do not respond to the notification within a timely manner, as determined solely by Contest Organizer, Contest Organizer may conduct additional random drawings to select additional potential winners. Potential winners must respond to the notification message and provide all requested information within forty-eight (48) hours of the first contact or attempted contact from Contest Organizer. Contest Organizer may require winner(s) to complete, sign, and return a Declaration and Release Form and other applicable documents (collectively, the "Forms"). All required documents must be completed and returned to Contest Organizer within two (2) days of the date and time listed on the documents. If a potential winner cannot be contacted, is disqualified, or fails to timely execute and return any required forms, an alternate winner may be selected from among the remaining eligible Entries. Only three alternate winners will be selected, after which unclaimed prizes will remain unawarded.

## 5. PRIZES; PRIZE TERMS:

There are Thirty (30) Prizes that are available to be won, comprising of the following:

**A. Grand Prize.** One (1) Grand Prize comprising of one (1) Five Thousand Canadian Dollar (CAD\$ 5,000) cheque (a "Grand Prize") is available to be won.

The estimated Approximate Retail Value ("ARV") of the Grand Prize is \$5,000.

**B.** <u>Secondary Prizes</u>. Twenty Nine (29) secondary prizes (each, a "<u>Secondary Prize</u>") are available to be won, each Secondary Prize comprising of one (1) Two Hundred and Fifty Canadian Dollar (CAD\$250) Walmart eGift Card.

This section does not limit any other consent an individual may give to the Contest Organizer or others with respect to the collection, use and/or disclosure of his/her personal information.

The Forms are the sole property of the Contest Organizer and will not be returned to Entrants at any time.

The Contest Organizer is the sole owner of the promotional materials and products of the Contest and of the intellectual property rights related thereto, and nothing in these Rules shall be construed as conferring any rights whatsoever on the Entrants in this regard.

Contest Organizer reserves the right to cancel or modify the Contest for any reason, including but not limited to, if fraud, misconduct or technical failures destroy the integrity of the Contest, or if a computer virus, bug, or other technical problem corrupts the administration, security, or proper administration of the Contest as determined by Contest Organizer, in its sole discretion. Contest Organizer reserves the right to disqualify or prohibit the participation of an individual if fraud or tampering is suspected, or if the individual fails to comply with any requirement of participation or with any provision in these Official Rules. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE OR UNDERMINE THE OPERATION OF THIS CONTEST MAY BE A VIOLATION OF CRIMINAL & CIVIL LAWS. SPONSOR RESERVES THE RIGHT TO DISQUALIFY AND/OR SEEK DAMAGES FROM ANY INDIVIDUAL MAKING ANY SUCH ATTEMPTS TO THE FULL EXTENT PERMITTED BY APPLICABLE LAW.

Contest Organizer reserves the right to disqualify or prohibit the participation of an individual if fraud or tampering is suspected; if the individual fails to comply with any requirement of participation or with any provision in these Official Rules; if the individual's behavior or communication at any point is disruptive, may or does cause damage or to any person, property, or reputation of Contest Organizer, or is otherwise not in accordance with all applicable laws and generally accepted social practices as determined in Contest Organizer's sole discretion.
